Discipline Updates

Upcoming Five (5) Year Reviews – Fall 2020

The Course Identification Numbering System (C-ID) is initiating the 5-year review of the descriptors and transfer model curriculum (TMC) for eleven (11) TMCs during the Fall 2020 term. The purpose of reviewing the C-ID descriptors and TMC on a 5-year cycle is two-fold:

1. to ensure that descriptors are current and reflect changes in the field that would necessarily impact curriculum
2. to provide an opportunity to revise elements of descriptors that were deemed problematic

We are now seeking input to determine whether or not changes are warranted and, if so, what those changes should be. The information gathered by the surveys will be reviewed by the Faculty Discipline Review Group (FDRG) and used to guide the 5-year review process.
