## Update on Approved Courses and TMCs

**Presently, 83 CCCs** have courses that have been granted C-ID numbers.

**1355** courses have been granted C-ID numbers in **15 disciplines**

**320 (140 AG) (+26 from May)** C-ID descriptors have been approved

**20** TMCs (Journalism approved but going through some fine tuning- to be posted soon)

Possibly **2 or 3** more to be considered in June or early Fall:

**385** AA-T and AS-T aligned degrees approved in the Chancellor's Office (as of 5/24/12)

## Nursing and Engineering FDRG meetings/conference calls planned for summer

Faculty from Nursing and Engineering met in May to begin discussions of statewide efforts to align their curriculum and develop course descriptors.

**Nursing** FDRG will meet in June to continue their efforts to develop draft descriptors needed for their lower division nursing curriculum and a possible TMC or model curriculum.

**Engineering** FDRG members met and will be working this summer on developing draft descriptors and draft TMC(s) or model curriculum to be posted in Fall 2012.

## Recent survey of CSU Articulation

**Officers** found that 6 CSU campuses have stated an increase in their CCC course articulation (some 370 courses) based on C-ID approved courses; 5 CSU campuses reported that they are just beginning the process now or this summer; much of the increased course articulation was reported to be with CCCs out of their immediate service area.
