Approval Dates: Non-TCSU courses with C-ID approval **do not expire**. Course outlines should be re-submitted if the local course outline was revised such that it warrants re-submission (as the result of a substantial local curricular change) or a descriptor is modified substantially enough to warrant re-submission. DISCIPLINE STATUS REPORT:

Agriculture

The Agriculture FDRG will meet in April to begin development of a TMC and any needed descriptors not already finalized.

Biology

BIOL 125S is vetting until **March 31st**. The FDRG is working to finalize BIOL 150 (Zoology/Animal Diversity) and BIOL 155 (Botany/Plant Diversity).

Chemistry

Descriptors for CHEM 101 (Intro to Chem), 102 (Intro to Organic and Biochemistry) and 103 (Survey of General, Organic and Biological Chem) are posted for vetting until **March 15th**. Coming soon: CHEM 130 (Quantitative Analysis) to be posted for vetting. The Chemistry TMC has been approved but is awaiting implementation of IGETC for STEM majors.

Economics

Discussion will soon continue for this FDRG regarding a draft TMC and descriptors.

Engineering

The Engineering FDRG will be reviewing descriptor and model curriculum feedback from vetting that closed on Feb. 15, 2013.

English

The English FDRG is reviewing descriptor feedback from vetting that closed on Feb. 15, 2013.

Information Systems

The Information Systems FDRG met this month to discuss a draft TMC and descriptors.

Kinesiology

Finalized movement/activity descriptors in the areas of Aquatics, Fitness, Individual/Dual Sports, Martial Arts/Combatives and Team Sports will be available for course submission in the near future.

Mathematics

Coming soon – Math 120 (Math Concepts for Elem Teachers) will finalize and a draft descriptor will vet for Math 955 - Precalculus and Trigonometry.

Nursing

The Nursing Model Curriculum and survey is posted for vetting until **March 15th**. Please encourage your nursing faculty to respond to the survey!

Radio/TV/Film
