## Update on Approved Courses

**Recently added filters make it easier for AOs to sort course information by discipline, college and date.**

- **72 CCCs** have courses that have been granted C-ID identifiers.
- **781** courses have been granted C-ID identifiers for **11 disciplines**.

## Important TCSU approval update

- If a course was automatically approved for C-ID due to it being approved by the CSU LDTP Project and granted a TCSU number, that course will be given a **five-year review** date from the date that the TCSU number was granted.
- TCSU approved courses with a date earlier than 6/30/2007 will be reviewed in Summer 2012.
- Courses that were granted TCSU numbers earlier than 2007 will not automatically be granted a C-ID designation and the course must be submitted for C-ID review through the C-ID website.
- We are currently working with our technology department to develop reports which will list your approved courses and their respective review dates.

## Descriptor Update

- Currently, C-ID has 248 approved descriptors and 77 draft descriptors on the website. The draft descriptors have a final review date of **October 16**.
- **Some of these descriptors were re-posted in Spring 2011 because of lack of faculty reviews and comments. PLEASE ask your faculty from these disciplines to go to the website and comment on these descriptors!!!!**
