### 1) CALL TO ORDER: President Pam Luster

### 2) OPERATIONS

a) Mesa Pathways Committee: The Vice President of Instruction, **Isabel O'Connor**, introduced the presentation on the **Mesa Pathways Committee (MPC) and workgroups Fall 2019 Semester summary**. The presentation included a report from Brave Communication, Guide Majors and Mapping, Onboarding and Career Exploration, and Proactive and Integrated Student and Academic Support workgroups. Each workgroup provided membership updates, goals, accomplishments, events/meetings, and next steps/action items for the Spring 2020 Semester.

A proposal for a Mesa Pathways Fellows Cohort (students who engage in meetings, support decision-making, help outreach to students and data-collect) will be brought to MPC tomorrow to finalize.

**Leading from the Middle (LFM) Fall 2019** update: **Michelle Toni Parsons**, co-chair of Mesa Pathways Committee, stated that LFM is led by the RP Group from the State Chancellor's office. It is a year-round leadership conference where a team applies to attend the academy and then the team creates a project/plan to bring back to their campus. The Mesa College LFM is developing a plan for "what we know is going on" at Mesa College and how Mesa Pathways will address those issues. Next steps for LFM include working on a design for a CANVAS shell for Mesa Pathways and collaborate with the Brave Communication workgroup for a MPC communication plan.

VPI **Isabel O'Connor** shared a slide of the names of those on campus who have been involved with Mesa Pathways and thanked them for their participation. On January 27, 2020, an all-flex event will be held on Mesa Pathways; an email providing additional information on the event will be sent.

b) Guided Pathways Essential Practices: Scale of Adoption Self-Assessment: Second Reading – VPI O'Connor who presented the **Guided Pathways Essential Practices: Scale of Adoption Self-Assessment** for a second reading. VPI O'Connor stated this document was brought to President's Cabinet for a first reading and has been reviewed by governance groups.
